## MODEL HORSE PROGRAM

#### **PROJECT OBJECTIVES:**

The purpose of the project is to help 4-H Club members to:

1. Build confidence and promote sportsmanship through model horse showing.

2. Gain knowledge of real horses through model horse showing and other planned activities.

3. Encourage creative minds and hands through model horse activities.

#### **REQUIREMENTS:**

1. Be a member of a 4-H club and attend meetings regularly or an Independent member.

2. Must attend either the Model Horse Clinic, Annual Model Horse Show, or both.

3. Follow the leadership of the project leaders and extension staff.

4. Complete a County Level Public Presentation, participate in Community Service, assist with the Model Horse events as needed, and keep an accurate and up to date record book.



### MODEL HORSE PROJECT INVENTORY

#### Herd Record - Start of Project Year (Do not include horses purchased this year)
